To prevent any unlawful advantage, the members are prohibited from trading ChargePanel stock based on insider information. Trading should only occur when relying on information that is publicly accessible. Furthermore, members must not disclose insider information to others, including friends or family members, as tipping others is illegal and considered insider trading.

These rules also apply if they become aware of insider information about other companies due to their role at ChargePanel. Insider trading is illegal in all forms, and compliance with these regulations is mandatory.
